Medicare covers vaccinations under either the Part B benefit, which is your Anthem Medicare Advantage Preferred PPO plan, or the Part D benefit, which is your SilverScript Medicare PDP plan. See page 2 for all the details.

- ▶ **Pneumococcal (Pneumonia Vaccine)**
- ▶ **Influenza (Flu shot)**
- ▶ **SARS-COV-2 (COVID-19) Vaccine**

## D MEDICARE PART D COVERAGE\*

Vaccines you can receive only at your pharmacy:

### WHAT:

- ▶ **Shingles Vaccine**
- ▶ **Tetanus, Diphtheria & Pertussis (Tdap)**
- ▶ **Measles, Mumps & Rubella (MMR)**
- ▶ **Other vaccines that are reasonable and necessary to prevent illness and are not covered by Part B**

**\*If you received a Medicare Part D vaccine at the doctor's office, you will be responsible for the out-of-pocket costs and would need to submit a paper claim to SilverScript at (833) 958-2660 for reimbursement. Please contact SilverScript if you have questions about submitting a reimbursement request for a Part D vaccine administered at a doctor's office.**
